In reference to District Plan Change 23 to 'The Reserve' of Fairlie township.

I have two titles on my property which I have paid for separately since purchasing this property with the full intention of building on the separate title. I also checked with Council before buying the property that I would be able to build or subdivide and was assured this wouldn't be a problem. The new proposed plans would affect my ability to build and reduce the value of my property significantly. I have recently had to settle with an ex partner on the value of my property, this plan change would reduce the value. Is someone going to compensate me for this? Whilst I can understand some of the changes for certain parts of the Mackenzie District, I believe change 23 does not suit 'The Reserve' of Fairlie. The proposed 4ha is an unrealistic size when as most plots are much smaller. A 3000-5000m<sup>2</sup> size is more realistic. With water and sewer connections run to the gate, it was always the intention for 'The Reserve' area of Fairlie to grow. Which now possibly won't happen. For obvious reasons I oppose this plan change and would like 'The Reserve' area to be reviewed to a more realistic size.
