## **Springwater Trust (ST)**

### **Submission to Mackenzie District Council (MDC) on Plan Change 25 (PC 25)**

#### **Introduction**

This paper submits on the PC, as requested by MDC for ratepayers to submit on the PC prior to 26 January 2024.

#### **Background**

ST has two properties located on Lyford Lane, 140c Lyford Lane and 147 Lyford Lane, located in the Hocken Lane Rural Residential Zone (**the Zone**) and owns several properties within the Twizel township.



ST is therefore particularly interested in Plan Change 27 and PC 25.

#### **ST's Submission**

1. MDC has presented to Lyford Lane residents a proposal to upgrade wastewater services to Lyford Lane to protect Twizel's town water supply (**the Proposal**). That matter is still being considered by MDC, who are considering various submissions from Lyford Lane residents.
2. ST, by virtue of its ownership of its Twizel township properties connected to the MDC domestic water system, is vitally interested in the outcome of the Proposal, and a satisfactory outcome that ensures the safety of those property's drinking water. A review of the material provided to ST by MDC, particularly the Twizel Drinking Water Safety Plan, indicates MDC has a high legal and moral responsibility to address the current wastewater issues on Lyford Lane (DWPZ and SWRMA Zone 2) for the safety of drinking water in the Twizel township.
3. A review of PC 25 indicates that several anomalies exist with the Zone relative to other Rural Residential Zones (RRZ) in the area, namely:
  - MDC provides no town water services to the Zone.
  - MDC does not own the essential infrastructure (including the access road) for the Zone, despite there being 21 lots.The Zone is therefore inconsistent with other RRZ of this scale and nature in the area.
4. Consequently, ST submits that:
  - a. PC 25 should be amended to provide that the MDC must provide satisfactory drinking water and waste-water reticulation to the 21 lots situated on Lyford Lane, and MDC should assume ownership of the bridges and road servicing Lyford Lane.

b. MDC should as a matter of urgency resolve the Proposal with Lyford Lane residents.
