## **RE: Further submission on Plan Change 20 to the Mackenzie District Plan**

1. Forest & Bird wishes to lodge a Further Submission on Plan Change 20 (PC20) to the Mackenzie District Plan.
2. Forest & Bird represents a relevant aspect of the public interest, and has an interest greater than the public generally.
3. Forest and Bird could not gain an advantage in trade competition through this submission.
4. Forest and Bird wishes to be heard in support of this submission, and would be prepared to consider presenting this submission in a joint case with others making a similar submission at any hearing.
5. Forest and Bird represents a relevant aspect of public interest as New Zealand's largest non-governmental conservation organisation with more than 100,000 members and supporters. Forest & Bird originally set out to protect New Zealand's unique flora and fauna the tasks of Forest and Bird in more recent years has extended to protecting and maintaining the environment surrounding the flora and fauna. Forest and Bird also made an original submission on other aspects of the current updating of the Mackenzie District Plan.
