Fairlie to Kimbell Central South Trail section now open



Have you checked out the newly opened shared-use Fairlie to Kimbell section of the Central South Trail yet? The trail provides a great off highway option for those walking or cycling between the towns. The trail section was officially opened on Sunday 10 September by Mackenzie District Mayor Anne Munro. In time, the trail is planned to extend further west towards Stoneleigh Road and bridge, and will eventually link up with the Lake Tekapo-Twizel section of the Alps 2 Ocean Cycle Trail.

Draft Responsible Freedom Camping Bylaw

Council is making a new bylaw under the Freedom Camping Act 2011. The new bylaw will be called the Responsible Freedom Camping Bylaw 2023. It carries over many of the provisions from the previous Responsible Freedom Camping Bylaw 2016.

Freedom camping has become a popular option for visitors throughout New Zealand and offers an affordable holiday for domestic and international visitors. The Mackenzie District is a popular destination for all types of visitors, which is why Council is proposing to have a mechanism to manage Freedom Campers.



The Council adopted a draft Responsible Freedom Camping bylaw for consultation following initial feedback from the community and external stakeholders.

- The draft bylaw includes:
- Moving freedom camping away from all three main townships in the Mackenzie District.
- Restricted camping will be provided at Lake Opuha (Bennetts Road, Haves Road, and Opuha George
- Road areas), and Edwards Stream (NZTA). Prohibiting tents, temporary structures, and non-self-contained vehicles throughout the Mackenzie
- District. Prohibiting the use of all open fires and firepits while freedom camping in the Mackenzie District.
- Explanatory notes to assist in better understanding of the Bylaw, including an explanatory note to let people know that Reserves in the Mackenzie District will be regulated under the Reserves Act 1977 rather than the Freedom Camping Act 2011, and that there will be provisions for restricted camping at the Lake Ruataniwha (West End) and Lake Wardell reserves.

We want to know what you think about safer speed limits in our district.

We know that lowering the speed on our roads makes things safer for pedestrians, cyclists, horseriders. We also know that slower speeds mean that when accidents do happen, less harm is caused. The Government recently introduced legislation to reduce the speed around schools to 30km/hour to protect children who, as every driver knows, can behave in unpredictable ways.

Council is now asking for you opinion on a draft speed management plan which would see speed limits reduced across our district, with particular emphasis on urban areas. Old Iron Bridge - Tekapo River





The Iron Bridge on the Pukaki River track, which crosses the Tekapo River, is one of Council's more unusual assets - the bridge is from the Ministry of Works days, sold to the Council many years back for a symbolic \$1 dollar.

This bridge is accessed from the Haldon Arm camp and crosses the lower Tekapo River, connecting Haldon Arm Road to 4x4 tracks across the river. The river usually runs low, however when there is spilling from Lake Tekapo the environment changes dramatically.

It is a bumpy trip from the Haldon camp along a riverbed surface for approximately 20 mins before turning onto more riverbed and crossing a couple of fords before reaching the bridge. Inspections are taken by Fulton Hogan on a six-monthly basis to check the condition of structure.

Public Notice of right to demand a poll

on Electoral System

Notice is given under section 28(1) of the Local Electoral Act 2001, that electors of the Mackenzie District Council have the right to demand a poll on the electoral system to be used at the next two triennial general elections (2025 and 2028) of the Mackenzie District Council.

The choice is between the First Past the Post (FPP) and the Single Transferable Vote (STV) electoral systems. Unless a poll determines otherwise, the First Past the Post (FPP) system will be used for the Mackenzie District Council.

Signed by at least five percent of eligible electors of the Mackenzie District Council. This will require a minimum of 170 elector

Every elector who signs a demand must also set out in it his or her full name and the address for which he or she is qualified as an elector of the Mackenzie District Council.
