

Further Submission By Bronwen Murray on Plan Change 28.

My submission is on the inundation zone of plan change 18 and supporting the submissions against the proposed restrictions and rules in the Hydro Inundation Zone

My interest in this issue is greater than that of the public as I live within the Hydro inundation zone.

In meridian's submission also representing Genesi they are requiring new and further rules to curtail the activities and lives living below their structures, surely the responsibility and ones is on them, two of New Zealand's larger public companies to ensure we and the public are safe from their structure. In reading what they and Council are proposing one can only conclude their structure is fragile and maintenance inadequate

The infrastructure on The Wolds in the zone pre-exists the canal system. In negotiations and subsequent compensation for the structure to be built on what was our land there, was no mention of the possibility of possible catastrophic failure or leaking and we were assured we would be safe in our bed's. If there had been we would have requested, they move all our infrastructure to a safe place. On our place in the zone there can be up to 20 people sleeping at any one time and an unknown number in the day depending on the time of year. There must also be consideration on the sheer numbers on the highway in the zone which don't ever appear in these issues, but I have calculated from observation in the hight of the tourist a failure could impact just in our zone at least 500 people. So my question to the panel is are you deciding more rules on us ensure the canal is safe or the imposition on subsequent rules curtailing our sustainability protecting two large corporations.

I am sure meridian are going to mention climate change it appears to be the catalyst for all rules currently. Yet the worst snow on The Wolds was in November 1965, and our worst flooding was 1980.
