#### Every sale of land should be notified:

The Council is in charge of public assets. The assets belong to the residents/ratepayers of a district.

If ever there is a disposal, a sale, proposed sale etc. of a land asset, real estate etc. then the Council shall notify through their website, publications etc. that this particular asset is coming up for potential sale.

This gives every person a right to inquire about, register an interest or even make an offer. This is the very base of a democracy – an open policy.

The remark that a sale cannot be notified because it is commercially sensitive is an excuse: every sale is potentially commercially sensitive...!

Council does not need to say who is interested to purchase the land, nor the proposed use, - **but** it should notified that an asset is up for disposal.

Anything else has got the stigma on an "insider deal" – behind closed door dealings...!

There have been some monumental blunders in the past.... - proposed development in LTK back in the early 2000 - the sale to the YHA is not far off.....!
