Immediate attention is required on this, MDC phoned me yesterday afternoon as they haven't heard from you. **A response is required by tomorrow 4<sup>th</sup> September** in accordance with s172 of the Resource Management Act 1991 as to whether TDC accepts the designation decisions in the proposed Mackenzie District Plan (MDP).

TDC did not make submission on the proposed MDP regarding the three designations (TDC1-3) and they were rolled over without modification. This was expected and the only changes made to the designation was prior to this when the landscaping conditions of the Richardsons Rd water storage site were changed (2023).

I don't see why TDC wouldn't accept the decisions – but TDC as the requiring authority needs to formally acknowledge and accept as above.

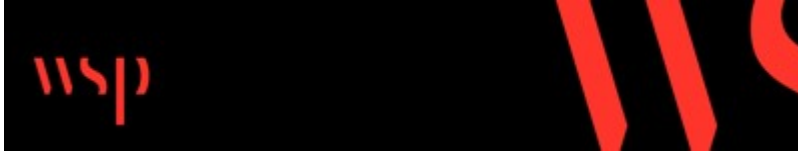
