1.: Consideration should be given for a 50 km per hour speed restriction through Town Centre, and a 'Round-about' and a pedestrian crossing for the ever increasing numbers of people crossing Main Highway opposite Aorangi Crescent to Shopping shopping area. Tekapo is one of the South Island's busiest towns.

2.: Close Pioneer Drive to Tourist traffic. To be restricted to pedestrian traffic (and residents cars) only.

No Tourist cars, buses or Camper Vans at least between Sealy Street and Mackenzie Street to protect Church environs and the strategic Green-area zone for future generations. It is New Zealand's most Iconic "Tourism" area - Number One in Japan and in China. This is the vision of not only the majority of Lake Tekapo residents, but the Nation - as expressed by the NZ Bus and Coach Assn, The NZ Tourist Export Council and other leaders in theTourism Industry. Their message - 'get rid of all pollution in this area - people need to walk to the Church and with its environs clear of all Car Parks and traffic". For example- it is critical there is no Tourist-vehicle parking at the Eastern side of the Footbridge otherwise visitors will have walk through hell to get to heaven. (e.g. A continual stream of 50 cars trying to access 20 Carparks - day and night !!) This whole area is fast becoming the Mackenzie's (and New Zealand's !!) most precious asset. Nurture it - don't ruin it.

3.: Improve connection for visitors around lake edge in front of CBD. (example - Wanaka) Landscaped parking at the lower levels obscured from Shopping area with landscaped lawns and picnic tables around the lake edge. Immense potential there with the right planning and community input

The flying Fox is very poorly situated and needs to be shifted so to be totally clear of the spectacular, iconic visual envelope. 4.Watering systems required for around the Commercial Business green areas and plantings. It was included in Bruce Scott's day with new and important plantings so unforgivable it is not being incorporated in current development. Critical. !
