Delegation to Hearing Commissioners: If you make a request under section 100A of the Resource Management Act 1991, you must do so in writing no later than 5 working days after the close of submissions and you may be liable to meet or contribute to the costs of the hearing commissioner or commissioners. A request cannot be made in relation to an application for a coastal permit to carry out an activity that a regional coastal plan describes as a restricted coastal activity.
 - Please note that Environment Canterbury delegates the functions, powers and duties to hear and decide the application(s) to one or more hearing commissioners where there are submitters to be heard and a hearing is required under s100 of the Resource Management Act 1991 (the RMA). Where there are no submitters to be heard and a hearing is not required the decision-making is undertaken by Council committee and/or delegated staff.
