Established in 1999, Totally Tourism (TTL) has been providing authentic experiences for Kiwis and international travellers by owning and operating some of New Zealand's original sightseeing and adventure businesses, including The Helicopter Line, Mitre Peak Cruises, Milford Sound Scenic Flights, Glacier Helicopters, Harris Mountains Heli Ski, Challenge Rafting, Queenstown Combos, and Alpine Guides.

Totally Tourism offers a portfolio of interconnected sightseeing and adventure activities, delivering unforgettable experiences with privileged access to outstanding locations for all ages and nationalities.

In the McKenzie District we operate from Mount Cook village, Mount Cook Airport, Glentanner Park and Pukaki Airport. (The Helicopter Line, Glacier Helicopters, Harris Mountains Heli Ski and Alpine Guides)

We own offices, hangers, and helipads to operate from and staff accommodation.

Our plant is specifically suited to our operations. For example, our radio networks and ICT systems have been designed and installed to overcome communications challenges in the Southern Alps. Our helicopters are suitable for our specialist operations.

In addition to tourism, we provide helicopter air support for search and rescue, police, emergency services, FENZ, and Civil Defence.

We have only recently been alerted to the submission process and are unable to provide a comprehensive submission. We do however wish to register our interest and to be kept informed of the outcomes.

As members of Aviation Industry Association, we support the points submitted by the NZHA relating to helicopter operations in the area.

We own two sections (double section) 2 DeHavilland Drive and 4 DeHavilland Drive at Pukaki Airport. We do not wish to see district plan or policy changes that impact on our ability to develop hangars and accommodation on the site as was proposed at the time of purchase or to reduce their value. There is an agreed helicopter taxiway next to the sections to hover taxi to the airfield which we wish to see retained.
