Yes, rather than borrowing money to fund some initiatives it would be more sustainable to live and spend within our means instead of burdening future ratepayers with additional financial burden. Theatre seats at Twizel Events Center are fine for now. No need for new road seal on beginning of SH80 that was put down on 23 February 2018 and SH8 on Twizel to Tekapo highway (the roads were fine! - if new seal is to be put down please put it where the road isn't in fine condition to start with). \$513,500 for landscaping in Twizel Marketplace? Why borrow for such non-essential initiatives?

The health of our waterways seems to have received only superficial mention, and that is purely reactive and to quote the plan p.9 "Meet legislative compliance" is a 'do just enough to stay out of legal trouble' rather than taking a leadership stance on improving our waterways under serious threat from over intensification of farming in the area. While a balance obviously needs to be struck in this area, the importance of protecting and enhancing our water catchment and waterways seems grossly under emphasised. This is not going to allow us to leave the area in better condition than we found it for future generations.
