#### **Inside an Emergency Response**

From Monday 18 July to Wednesday 20 July Council 'activated' the Civil Defence 'EOC' to deal with the weather event. But what does that mean?

Essentially a group of Council staff and other experts gather to pool information and resources to manage the work that needs to be done in the best way possible. We call this 'activation'. The room where we meet and operate out of is called an EOC 'Emergency Operations Centre'.

There is usually a wide range of experiences and expertise in an EOC, and within we had the full range – Bernie Haar is a veteran with 51 years' experience working for local councils and managing emergency situations. Isaac Ryall is an intern working at Council during school holidays to support our IT department and this was his first experience of helping with a Civil Defence event.

Isaac, who made sure all the technology was working said, 'this was a really interesting learning experience and I enjoyed seeing how everything came together.'

### Genesis Tekapo Township Fund grants

The Lake Tekapo Kindergarten received a \$5000 grant from Genesis Tekapo Township Fund in 2021, with the funds received put into a new outdoor native plant area. Photos show the plant area under construction, assisted by students from the Kindergarten.

### **Public Health Notice**

Some plumbing fittings have the potential to allow minute traces of metals to accumulate in water standing in the fittings for several hours.

Although the health risk is small, the Ministry of Health recommends that you flush a cup-full of water from your drinking water tap each morning before use to remove any metals that may have dissolved from the plumbing fittings.



We are recommending this simple precaution for all households, including those on public and private water supplies.


# **Pre-election Report**

The 2022 Pre-election Report provides residents and ratepayers with information on the key challenges and opportunities facing our District as we head toward the Council tri-annual elections this October.

The Pre-election Report contains the following information:

- A report on compliance with Council's Financial Strategy set out in the 2018-2028 and 2021-2031 Long Term Plans. This includes a comparison of limits on rates, rate increases, debt and returns on investments and financial prudence benchmarks.
- A summary of key projects, challenges and opportunities.
- Financial statements for the three years preceding the election year, budgeted financial statements for the election year, and forecast financial statements for the three years following the election year.
- Details of the major projects planned to follow the election, including their rationale and costs.

The report is intended to help provide voters with the information they need to make informed decisions at election time. It is also offered as an overview to election candidates, setting out the Council's existing and future challenges and opportunities in a politically neutral context.



# Greater access for

### rural voters

Rural folk in the Mackenzie District will get a greater say in democracy at this year's local government elections.

For the first time, voters who live in rural areas surrounding the townships of Twizel, Tekapo and Fairlie will be able to nominate and elect the members of those town's community boards.



The change comes due to public feedback received as part of a representation review held by Mackenzie District Council last year.

Council chief executive Angela Oosthuizen says at the last election only ratepayers living inside the town boundaries were able to vote for community board members. However, everyone in an area, including rural folk, used town facilities like swimming pools and parks and wanted to have a say on how they were run. The council put a proposal to the Local Government Commission to expand community board boundaries to include rural areas, and this was accepted.

"I hope rural ratepayers get a pleasant surprise when they open their voting papers this year and see they can vote for community board members," says Mrs Oosthuizen. "But I'm also hoping we get some rural people stepping forward to stand for election as well, because it's a good opportunity for them to get involved in their community."

# Elections are being held for:

#### Mayor

Provides leadership to the other councillors, is a leader in the community and performs civic duties.

#### Councillors

Representing our three wards of Opuha (3), Pukaki (3) and Tekapo (1). Their role is to focus on strategic issues and regional plans, set policies, make regulatory decisions and review council performance.

#### **Community Boards**

Community Board Positions are available across the three boards of Twizel, Tekapo and Fairlie. Their purpose is to represent and act as an advocate for their community, provide an overview of local services and engage with community groups.

# Annual Plan 2022/23

In the years when we do not produce a Long Term Plan, an Annual Plan is prepared to detail the work programme and expenditure for the coming year. The Annual Plan provides up to date budgets and information on specific areas of work Council plans to undertake for the next financial year.

The Annual Plan highlights any variations for the coming year from what was proposed in the Long Term Plan 2021-2031.

Where there are significant variations, reasons are provided as well as the financial impact of these changes.

The financial year beginning 1 July 2022 is the second year of Mackenzie District Council's Long Term Plan 2021-2031.

The Long Term Plan sets out the Council's ten-year budget and work programme and is updated, in consultation with the community, every three years.

# **Proposed Plan Change 20 - Strategic Direction Chapters**

Pursuant to Clause 5 of the First Schedule of the Resource Management Act 1991, the Mackenzie District Council (the Council) gives public notice of proposed Plan Change 20 to the Mackenzie District Plan.

Proposed Plan Change 20 is part of Stage 1 of the review of the Mackenzie District Plan and proposes to delete the following sections of the Mackenzie District Plan:

- Section 1 Introduction
- Section 3 Definitions (in
- Section 2 Policy and Legal
- part)Section 4 Takata Whenua

The Plan Change has been drafted in accordance with the National Planning Standards and proposes to add the following changes to the Mackenzie District Plan:

Part 1 – Introduction and General Provisions

Part 2 – District-wide Matters

Strategic Direction

- Introduction
- How the Plan Works
- Interpretation (in part)
- National Direction
   Instruments
- Mana Whenua

These are the only changes within the scope of Plan Change 20, and changes to other provision of the Mackenzie District Plan are not within the scope of Plan Change 20.

#### Submissions

Any person may make a submission on proposed Plan Change 20. Where a person can gain advantage in trade competition through a submission, then the person may only do so if the person is directly affected by an effect of the Plan Change that adversely affects the environment; and does not relate to trade competition or the effects of trade competition.

A submission may be made via email and/or post.

Submissions must be in the format prescribed by Form 5 and must state whether or not you wish to be heard on your submission. Submission forms can be downloaded from Council's Website at www.mackenzie.govt.nz. Paper submission forms are also available at the Council Offices in Fairlie and Twizel.

# The closing date for lodging a submission is 5.00pm, Friday 9 September 2022.

Once the closing date for submissions has passed, Council will publicly notify all submissions received, prepare a summary of submissions, and will allow a period for further submissions in support of, or in opposition to, those submissions already made.

A Council hearing for Plan Change 20 will then be arranged to consider all submissions. Anyone who has made a submission and indicated that they wish to be heard will have the right to attend the hearing and present their submission.

Any person who has made a submission has the right to appeal against the decision on the Plan Change to the Environment Court if in relation to a provision or matter that is the subject of the appeal, the person referred to the provision or matter in the person's submission on the proposal.
