

## Open Space Zone (OSZ)

### Introduction

The Open Space Zone encompasses areas of ~~green~~ open<sup>1</sup> space which provide for passive recreation opportunities, including walking and cycling connections in urban areas. Use of these areas is generally informal in nature. The Open Space Zone is located within, or adjoining the District's town and settlements.

Limited built form is anticipated in this zone to support the recreational focus, such as seating, picnic and barbeque facilities, toilets, shelters and playground or sporting or other recreation<sup>2</sup> equipment, reflecting the dominance of open space.

In lakeside areas, the maintenance of lake views and accessibility to the lake is also important.
