**Plan Change 24 – Sites and Areas of Significance to Māori
(SASM)**

Final for Notification

4 November 2023

Proposed Plan Change 24 is part of Stage 3 of the review of the Mackenzie District Plan and includes in its scope the following changes to the Mackenzie District Plan. Changes to other provisions of the Mackenzie District Plan are not within the scope of Plan Change 24.

1. Plan Change 24 Changes

- 1.1. Insert a new 'Sites and Areas of Significance to Māori' Chapter (SASM) within a new 'Historical and Cultural Values' section in 'Part 2 – District-Wide Matters', as set out in the EPlan.
- 1.2. Add the definitions, as set out in the EPlan, to the Definitions Chapter (within the 'Interpretation' section in 'Part 1 – Introduction and General Provisions').
- 1.3. Add the glossary terms, as set out in the EPlan, to the Glossary Chapter (within the 'Interpretation' section in 'Part 1 – Introduction and General Provisions').
- 1.5. Amend the following definitions within the Definitions Chapter (within the 'Interpretation' section in 'Part 1 – Introduction and General Provisions') to apply to the Sites and Areas of Significance to Māori chapter:
 - building
 - environment
 - operational need
 - residential unit

Note - The scope of PC24 in relation to the above definitions is limited to the application of the definition to the Sites and Areas of Significance to Māori chapter and does not extend to changes to the definition as it applies to other chapters which are not part of Stage 3 of the District Plan review.

- 1.6. Amend the terms 'taoka' and 'Te Manahuna', within the Glossary Chapter (within the 'Interpretation' section in 'Part 1 – Introduction and General Provisions') as follows:
 - **taoka** – ~~Treasure~~ Treasured possessions, both tangible and intangible.
 - **Te Manahuna** - The Mackenzie ~~Basin~~ District.
 - 1.7. Amend the Planning Maps to insert a new SASM mapping overlay which identifies the properties that consist of culturally significant sites and areas as set out in Schedules SASM-SCHED1, SASM-SCHED2, SASM-SCHED3, and SASM-SCHED4 within the SASM Chapter.
 - 1.8. Delete the following definitions from Section 3 of the Operative District Plan:
 - Hapu*
 - Iwi*
 - Kai Tahu (Ngai Tahu)*
 - Kaitiaki*
 - Kaitiakitoka (kaitiakitonga)*
 - Kati Huirapa*

- Kaumatua*
- Koiwi Takata*
- Mahika (Mahinga) Kai*
- Mana whenua*
- Takata Whenua (tangata whenua)*
- Taoka (taonga)*
- Te Waipounamu*
- Tikaka Māori*
- Tino rakitirataka (rangitiratanga)~
- Waahi tapu*

Notes –

*Terms marked with a * above are proposed to be deleted from Section 3 and included in the Glossary Chapter (within the 'Interpretation' section in 'Part 1 – Introduction and General Provisions'), rather than being deleted altogether.*

The deletion of the term marked with a ~ above is to remove duplication of terms across multiple Plan Changes. The term to be deleted was introduced in the explanatory section of Plan Change 20 and therefore, does not require a separate definition.

1.9 Amend the following definitions in Section 3 of the Operative District Plan so that they do not apply to the SASM chapter:

- Earthworks
- Forestry Activity
- Wetland
