# FREEDOM CAMPING BYLAW - DELEGATION TO CHIEF EXECUTIVE OFFICER:

The purpose of this report is to amend the Delegations Manual to provide delegation to the Chief Executive Officer to temporarily close freedom camping sites under the Freedom Camping Bylaw 2014.

# Resolved:

2. That the Council agrees to amend the Delegations Manual to provide delegation to the Chief Executive Officer to exercise functions in respect of Clause 9 of the Freedom Camping Bylaw 2014; being:

Authority to temporarily close or restrict entry to any overnight freedom camping area or part of any freedom camping area where such restriction is considered necessary by the Chief Executive Officer to:

- (a) prevent damage to the local authority area or facilities in the area; or
- (b) allow maintenance to the local authority area or facilities thereon; or
- (c) protect the safety of persons or property; or
- (d) allow or facilitate public access.

FREEDOM CAMPING BYLAW - TEMPORARY CLOSURE HAMILTON DRIVE:

The purpose of this report is to seek Council endorsement of the decision to temporarily close the freedom camping site at Hamilton Drive, Tekapo.

Cr Jackson asked if temporary closure was for a set period of time. The chief executive said the period of time was until the strategy was reviewed in April. If the review of the strategy recommends a review of the bylaw then it will remain closed until the bylaw is reviewed.

The Mayor asked Toni Morrison to explain the process of reviewing the strategy. This will be an opportunity for people to provide feedback.

Cr Cox said since the Hamilton Drive carpark was closed to camping more people were using the site during the day as it should be used. Cr Smith asked if freedom camping problems have broken out elsewhere. He said it's like a balloon, if you squeeze one area it pops out somewhere else. Cr Leslie said problems have occurred in Twizel.

The Mayor said Mayors are taking a coordinated approach with the government. She has been in touch with Mayors of other high tourism places and they are working together on the issue.
