Submissions welcomed for the Heritage **Protection Fund**





Council approved a grant for a partial contribution towards the earthquake strengthening of Anniss Cobb Cottage, Burkes Pass. The grant was used to purchase special screws designed for earthquake strengthening. One photo shows a sample of the 1.2 m Helifix screws used, and the other of one of the many screws being drilled vertically into the cob wall.

Council are currently taking submissions for the Heritage Protection Fund. This fund is available to assist and actively encourage property owners and members of the Mackenzie community to manage, maintain, preserve and enhance the heritage values of items or areas. It provides a partial contribution towards the costs of a specific project related to a building, item or place.

The fund is allocated \$5000 each financial year by Council which is then contestable by applicants.

Eligible for funding are: Buildings, items or places listed on the Heritage Items Schedule of the District Plan, Trees listed in the Protected Trees Schedule and archaeological sites and wahi tapu sites as identified by the New Zealand Historic Places Trust. Projects eligible may be: preservation/conservation projects, enhancement/management projects or research and education projects. The fund does not apply to projects that will demolish or remove buildings or items, or add or extend buildings or items, nor any work that has been completed prior to the consideration of an application. However, Council does reserve a right to consider these types of projects for funding if appropriate circumstances exist.

At least two quotes must be supplied that provide a breakdown of the costs. The criteria and amount of funding available for different categories of heritage items is provided in the Policy, as well as a full breakdown of the information that needs to be attached with an application.

Council calls for applications to be made for the Heritage Protection Fund in March each year. The applications are presented at a Council Meeting. Information provided will be publicly available as it will be a part of the Council Agenda.

Fairlie water - understanding water restrictions.

You may have seen our recent notices about the need for some water restrictions in Fairlie asking residents conserve water where they can. This caused some comment and we received a number of questions. Like any District Council, our consent to take water from the environment is controlled by our Regional Council - in our case Environment Canterbury.

A water consent comes with conditions that we are

required to adhere to, and which are monitored by the

Regional Council. The relevant conditions in this case

are about the amount of water we are allowed to take

from the environment.



Water Restrictions

The amount we can take depends on the 'unmodified' flow of the Opihi River measured at the SH1 bridge at Temuka. 'Unmodified' means the flow (as calculated by Environment Canterbury) that would be in the river if the Opuha dam was not there.

Our consent allows us to take 28 litres/sec under normal conditions. However, when the river flow drops to 8.1m3/sec the maximum we can take is reduced to 21 litres/sec, and when the river flow drops to 2.5m3/sec, we can only take 14 litres/sec. These limits are intended to preserve adequate environmental

Council staff monitor the flow levels in the river and our consumption daily to make sure that we stay within these conditions. When we have to reduce our water take we publish notices asking residents to save water. One of the ways we do this is via our water restrictions noticeboards (see picture). We have plans to install more of these around the district.

Typically we ask residents to limit the amount water they use on their lawns and their use of sprinklers and hoses.

Our consent was issued in 2009 and expires in 2044. In 2017 we successfully renegotiated the clauses around water take to ease the original more restrictive limitations.
