1. Haldon Station Limited wishes to be a party to the appeal ENV-2021-CHC-91
2. Haldon Station Limited has an interest in the proceedings that is greater than the interest that the general public has. This interest is based on the grounds that Haldon Station Limited owns and runs a mixed farming business at Haldon Station, Haldon Road, Mackenzie Country and its land stewardship and farming operations are directly impacted on by the subject matter of the Appeal.
3. Haldon Station Limited is not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.
4. Haldon Station Limited is interested in all of the proceedings.
5. Haldon Station Limited supports the relief sought by Meridian Energy Limited and in particular supports the relief sought in relation to the deletion of figure 1 and subsection (c) from the definition of 'significant indigenous vegetation and significant habitats of indigenous fauna' on the basis that the map relied upon has not been properly consulted upon or checked against the actual areas of land it purports to represent.
6. Haldon Station Limited agrees to participate in mediation or other alternative dispute resolution of the proceedings.
