### 1. Introduction

Genesis Energy Limited (**Genesis**) welcomes the opportunity to submit on Proposed Plan Change 22 (**PC22**) relating to the Light Chapter in the Mackenzie District Plan.

Genesis is an electricity generator and energy retailer with a diverse portfolio of renewable and thermal electricity generation assets. The generation profile of Genesis comprises a range of energy sources including hydro, thermal and wind across New Zealand.

In the Mackenzie district, Genesis owns and operates the Tekapo Power Scheme (**TekPS**, the **scheme**), which is a part of the nationally significant Waitaki Power Scheme.

In addition to its existing generation assets, Genesis is continuously reviewing opportunities for future development of renewable energy. It is in the context of providing for both the existing and potential new generation opportunities that Genesis makes this submission on PC22.

Section 2 of the submission outlines Genesis' specific submission points and relief sought.

Genesis <u>wishes to be heard</u> in support of this submission. If others make a similar submission, Genesis would be prepared to consider presenting a joint case with them at any hearing.

### 2. Submission and Relief Sought

Genesis has previously provided initial feedback to the Council on the proposed light chapter.

As noted, the TekPS is fully located within the Aoraki Mackenzie International Dark Sky Reserve. Genesis has existing procedures in place to minimise light emissions from the Scheme. Genesis' focus on the new lighting provisions relate to the following:

- Operational requirements including the need for the power stations to operate 24-hours a day where existing large windows on the power station buildings may result in light spillage from an internal light source, and exterior lighting across the asset for operational safety, security and maintenance purposes.
- Project requirements where additional external light sources may be required in circumstances such as project or outage work that require night-time work on a limited basis.

With consideration to the above, Genesis' specific submissions are outlined in the table below.
